

# RSPCA NSW Inspectorate Annual Report 2024-2025

Submitted in accordance with section 34B(3)  
of the *Prevention of Cruelty to Animals Act 1979* (NSW)

**(1) Information pursuant to clause 41(1) of the *Prevention of Cruelty to Animals Regulation 2025* (NSW):**

**(a) complaints received, and investigations undertaken, about the treatment of animals:**

Between 1 July 2024 and 30 June 2025 (**reporting period**), RSPCA NSW received a total of 17,946 complaints alleging cruelty to animals contrary to the *Prevention of Cruelty to Animals Act 1979* (NSW) (**Act**), the *Prevention of Cruelty to Animals Regulation 2012* (NSW) and/or the *Prevention of Cruelty to Animals Regulation 2025* (NSW) (**Regulation**).<sup>1</sup> These complaints often involved more than one animal and multiple complaint types.

**(b) animals seized or taken possession of under the Act:**

Between 1 July 2024 and 30 June 2025, RSPCA NSW seized or took possession of 3,650 animals under the Act.

**(c) cautions given:**

RSPCA NSW interprets clause 41(1)(c) of the Regulation as a reference to official cautions issued pursuant to section 19A of the *Fines Act 1996* (NSW). During the reporting period, RSPCA NSW issued 11 such official cautions.

Between 1 July 2024 and 30 January 2025, the *Prevention of Cruelty to Animals Regulation 2012* (NSW) applied. Unless otherwise specified or implied by context, references to 'the Regulation' include the *Prevention of Cruelty to Animals Regulation 2012* (NSW) as applicable during the reporting period.

**(d) notices issued:**

RSPCA NSW interprets clause 41(1)(d) of the Regulation as a reference to written notices issued pursuant to section 24N of the Act. During the reporting period, RSPCA NSW issued 1,320 such notices.

**(e) proceedings for offences instituted:**

Between 1 July 2024 and 30 June 2025, RSPCA NSW commenced 156 prosecutions.

**(f) the organisation's officers and the training provided for the officers:**

Officers

As at 30 June 2025, RSPCA NSW had a total of 40 officers. Of those 40 officers, 39 are holders of a prescribed authority under the provisions of Part 2A of the Act, issued with the approval of the Minister for Agriculture. One officer was awaiting their prescribed authority as at the end of the reporting period.

RSPCA NSW received 23 complaints during the reporting period.

**(2) Information pursuant to clause 41(2) of the *Prevention of Cruelty to Animals Regulation 2025* (NSW):**

**(a) a statement of the number of, and a summary of the substance of, complaints relating to animal cruelty or mistreatment received by the organisation during the reporting period for the report:**

Between 1 July 2024 and 30 June 2025, RSPCA NSW received a total of 17,946 complaints alleging cruelty to animals contrary to the Act and/or the Regulation. These complaints often involved multiple animals and multiple complaint 'codes'. Complaint codes designate the substance of a complaint and are assigned when a complaint is lodged.

The following table shows the numbers and types of complaints received by RSPCA NSW during the reporting period, noting that multiple complaint codes may be assigned to a single complaint:

**(b) a statement of the number of visits or investigations made by the organisation’s officers as a result of the complaints during the reporting period for the report:**

Of the 17,946 cruelty complaints received, 992 were finalised as Intel Only, 170 were referred to other agencies, and 71 were directed to NSW Police. The remaining 16,713 cruelty complaints proceeded to investigation by RSPCA NSW.

**(c) a statement of the number of visits or investigations made by the organisation’s officers during the reporting period for the report that were unrelated to the complaints. Examples— routine inspections of abattoirs, pet shops or saleyards:**

Between 1 July 2024 and 2 April 2025, inclusive, RSPCA NSW’s AnimalOS database did not have the capacity to distinguish between inspections arising from cruelty complaints and ‘routine’ (that is, proactive) inspections conducted on animal trades under the provisions of section 24G of the Act. That capability was introduced on 3 April 2025.

Between 3 April 2025 and 30 June 2025, RSPCA NSW conducted 4 ‘routine’ inspections.

Prior to 3 April 2025, data on ‘routine’ inspections was derived from statistics manually reported by RSPCA NSW inspectors. The statistics for 1 July 2024 to 2 April 2025 are known to be incomplete. They may also be inaccurate due to ambiguity regarding the term ‘routine’, which can be interpreted as a reference to a complaint’s triage level as well as a proactive inspection. Based on this method, RSPCA NSW conducted 49 ‘routine’ inspections during the reporting period.

The capacity to conduct ‘routine’ inspections is dependent on available resources, with the investigation of animal cruelty complaints taking priority.

**(d) a statement of the number of persons officially cautioned by the organisation’s officers during the reporting period for the report:**

RSPCA NSW issued 11 official cautions pursuant to section 19A of the *Fines Act 1996* (NSW) during the reporting period.

**(e) a statement of the number of notices issued by the organisation's officers under the Act, section 24N during the reporting period for the report:**

RSPCA NSW issued 1,320 written notices pursuant to section 24N of the Act during the reporting period.

**(f) a statement of the number of animals seized or taken possession of under the Act and the number of days for which the animals remained in the organisation's possession or care:**

RSPCA NSW seized or took possession of 3,650 animals under the Act during the reporting period. When calculating days in care, RSPCA NSW does not have the ability to isolate those 3,650 animals from animals that were seized or taken possession of under the Act prior to 2024/25. RSPCA NSW recorded 313,242 days in care for all Inspectorate animals (including animals seized or taken possession of in earlier financial years).

**(g) a statement of the number of penalty notices issued by the organisation's officers during the reporting period for the report:**

During the reporting period, RSPCA NSW issued 127 Penalty Infringement Notices.

**(h) a statement of the number of proceedings for offences under the Act or the regulations instituted by the organisation's officers, including details of the defendants and the charges, during the reporting period for the report:**

RSPCA NSW instituted 156 criminal prosecutions during the reporting period against a total of 211 defendants. This brought the total number of active RSPCA NSW prosecutions in the reporting period to 226, noting that 70 prosecutions commenced prior to 2024/25 had not been finalised as at the date of the previous report.

Details of the proceedings, defendants and charges are provided at *Appendix 1 – Prosecution Results 2024/2025*.

**(i) details of the outcome of proceedings referred to in paragraph (h) that had been finally determined by the date of the report:**

Of the 156 prosecutions commenced during the reporting period, 69 had been finalised as at 30 June 2025, while 87 were pending final determination.

Of the 69 prosecutions finalised:

- 49 were determined following a plea of guilty,
- 1 was determined with a finding of guilt after hearing,
- 16 were heard and determined in the accused's absence pursuant to section 190 or 196 of the *Criminal Procedure Act 1986* (NSW), and
- 3 were withdrawn.

Of the 69 prosecutions finalised, three involved appeals by the defendant to the District Court.

**(j) details of the outcome of proceedings for offences referred to in the immediately previous report that had not been finally determined by the date of the previous report:**

As noted above, RSPCA NSW had 226 active prosecutions during the reporting period. Seventy (70) of those were commenced prior to 2024/25 and are detailed in *Appendix 1 – Prosecution Results 2024/2025*.

Of the 70 prosecutions that had not been finally determined by the date of the previous report, 53 had been finalised by 30 June 2025, while 17 were still ongoing.

Of the 53 prosecutions finalised:

- 35 were determined following a plea of guilty,
- 5 were determined with a finding of guilt after hearing,
- 5 were heard and determined in the accused’s absence pursuant to section 190 or 196 of the *Criminal Procedure Act 1986* (NSW),
- 1 was withdrawn, and
- 7 were dealt with pursuant to section 14 of the *Mental Health and Cognitive Impairment Forensic Provisions Act 2020* (NSW).

Of the 53 prosecutions finalised, nine involved appeals by the defendant to the District Court.

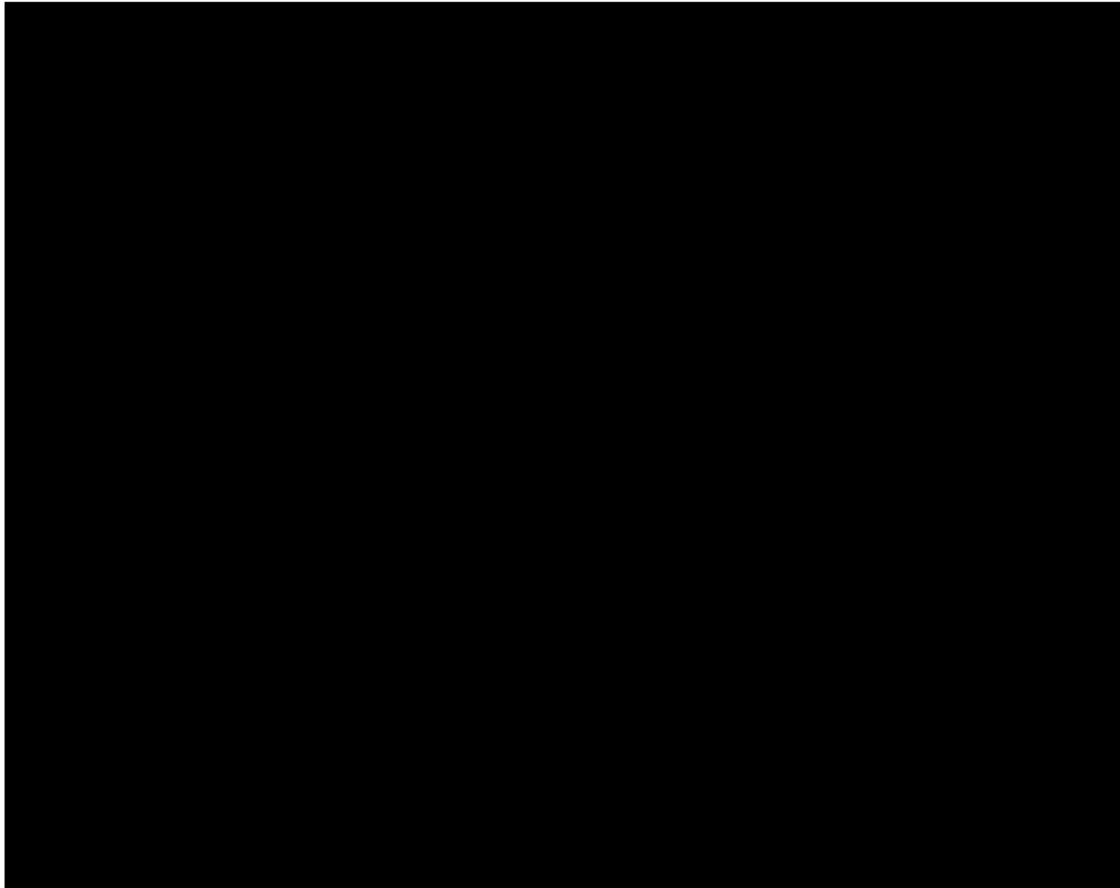

1.	Complaint	Person of interest (POI) complaint received regarding seizure of cat from property without consent.
	Outcome	An investigation was conducted, including reviewing job details, notebook entries and actions by the Inspector. A determination was made that the complaint was unsubstantiated. This matter remains under investigation.
2.	Complaint	A complaint was received from a member of the public (MOP) regarding an Inspector not attending to a cruelty complaint to their satisfaction.
	Outcome	An investigation was conducted, including reviewing job details, photographs and information was provided by the Inspector. A determination was made that the complaint was unsubstantiated.
3.	Complaint	A complaint was received from a POI regarding the actions of an Inspector during an emergency situation, as well as concerns about the seizure of their dog.

	Outcome	An investigation was conducted, including reviewing job details, body worn camera footage and information was provided by the Inspector that attended the cruelty complaint. A determination was made that the complaint was unsubstantiated. This matter is currently before the NSW Local Court.
4.	Complaint	A complaint was received from a POI claiming the re-visits to their property were unnecessary.
	Outcome	An investigation was conducted, including reviewing job details, notebook entries and actions by the Inspector. A determination was made that the complaint was unsubstantiated.
5.	Complaint	Complaint made by POI regarding the conduct of an Inspector during an investigation.
	Outcome	An investigation was conducted, including reviewing job details, body worn camera footage and information was provided by the Inspector that attended the cruelty complaint. A determination was made that the complaint was unsubstantiated.
6.	Complaint	A complaint was received from a POI claiming the Inspector illegally visited their home.
	Outcome	An investigation was conducted, including reviewing job details and information was provided by the Inspector. A determination was made that the complaint was unsubstantiated.
7.	Complaint	A complaint was received from a MOP claiming the Inspector did not collect an abandoned dog.
	Outcome	An investigation was conducted, including reviewing job details, notebook entries and information was provided by the Inspector. A determination was made that the complaint was unsubstantiated.
8.	Complaint	A complaint was received from a POI alleging that an Inspector was inappropriate in a conversation with them during an investigation. They also alleged that the Inspector had attended the property before a complaint was received.
	Outcome	An investigation was conducted, including reviewing job details, notebook entries and information was provided by the Inspector. A determination was made that the complaint was unsubstantiated.
9.	Complaint	Complaint made by POI regarding the conduct of an Inspector.
	Outcome	An investigation was conducted, including reviewing job details, review of body worn camera footage and information was provided by the Inspector that attended the cruelty complaint. A determination was made that the complaint was unsubstantiated.
10.	Complaint	Complaint made by POI regarding the conduct of an Inspector when answering the phone.
	Outcome	An investigation was conducted. A determination was made that the complaint was unsubstantiated.

11.	Complaint	A complaint was received from a MOP claiming the Inspector did not proceed with investigations on an act of cruelty to a cat.
	Outcome	An investigation was conducted, including reviewing job details, notebook entries and information was provided by the Inspector. A determination was made that the complaint was unsubstantiated.
12.	Complaint	POI complaint received regarding seizure of animals.
	Outcome	An investigation was conducted, including reviewing job details, notebook entries and information was provided by the Inspector. A determination was made that the complaint was unsubstantiated. This matter is currently before the NSW Local Court.

	Outcome	An investigation was conducted, including reviewing job details, notebook entries and information was provided by the Inspector. A determination was made that the complaint was unsubstantiated.
14.	Complaint	Complaint made by POI regarding the conduct of an Inspector referring to the Inspector swearing.
	Outcome	An investigation was conducted, including reviewing job details, review of body worn camera footage and information was provided by the Inspector that attended to the cruelty complaint. A determination was made that the complaint was unsubstantiated.
15.	Complaint	Complaint made by MOP regarding the conduct of an Inspector, not taking a complaint seriously.
	Outcome	An investigation was conducted, including reviewing job details and information was provided by the Inspector. A determination was made that the complaint was unsubstantiated.
16.	Complaint	A complaint was received from a MOP claiming the Inspector was not returning their calls regarding abandoned dogs/cats.
	Outcome	An investigation was conducted, during which the Team Leader advised MOP that the inspector was no longer working at RSPCA NSW, and another Inspector had taken over this job. Accordingly, the phone number that the MOP was using was no longer operational. A determination was made that the complaint was unsubstantiated.
17.	Complaint	A complaint was received from an informant alleging an Inspector had disclosed their information to a POI.
	Outcome	An investigation was conducted, and the Inspector provided information about the matter, including admitting an error when providing footage of an unwell animal to a POI. The Inspector acknowledged their error immediately. A determination was made that the complaint was substantiated. The staff member was counselled by the Chief Inspector and committed to reviewing SOPS and internal documents. The Chief Inspector advised the informant of the determination, who communicated they were satisfied with outcome.

18.	Complaint	POI complaint received alleging that a cat and dogs had been seized “under false pretences”.
	Outcome	An investigation was conducted, including reviewing job details, notebook entries and information was provided by the Inspector. A determination was made that the complaint was unsubstantiated. This matter is currently before the NSW Local Court.
19.	Complaint	POI complaint received regarding seizure of dog from property.
	Outcome	An investigation was conducted, including reviewing job details, notebook entries and information was provided by the Inspector. A determination was made that the complaint was unsubstantiated. This matter proceeded to prosecution before the NSW Local Court and is now finalised.
20.	Complaint	POI complaint received alleging a trespass.
	Outcome	An investigation was conducted, including reviewing job details and discussions with the Inspector that attended to the cruelty complaint. A determination was made that the complaint was unsubstantiated.

	Outcome	An investigation was conducted, including reviewing job details, review of body worn camera footage and discussions with the Inspector that attended to the cruelty complaint. A determination was made that the complaint was unsubstantiated.
